

AN ORDINANCE ADOPTING THE CITY OF HUNTERS HOLLOW, KENTUCKY, ANNUAL BUDGET, FOR THE FISCAL YEAR JULY 1, 1985, THROUGH JUNE 30, 1986, BY ESTIMATING REVENUE AND RESOURCES AND APPROPRIATIONS OF FUNDS FOR THE OPERATION OF CITY GOVERNMENT.

 $\ensuremath{\mathsf{WHEREAS}},$ an annual budget proposal and message has been prepared and delivered to the City Council; and

WHEREAS, the City Council has reviewed such budget proposal and made necessary modifications.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Hunters Hollow, Bullitt County, Kentucky, as follows:
